ELIGIBILITY REQUIREMENTS		
1. Mares must be registered with the KFPS		
2. Owner of record must be a current FHANA member		
3. The following mares are pre-qualified: Mares already holding the title of Model, Kroon, Provisional Model or Provisional Kroon are eligible and will be entered in their appropriate class by age group. A copy of their registration certificate must be sent with entry to prove eligibility.		
4. All Mares newly named as Model, Kroon, Provisional Model, Provisional Kroon or Star during the 2016 FHANA inspection Season are also eligible to enter and will show with other mares in the same age group. Entry form must specify the mare's 2016 predicate and inspection site for verification of eligibility.		
5. When mares come to the paddock area just prior to their class, a copy of their registration certificate must be presented to the FHANA representative, who will verify that their microchip matches their paper.		
6. Classes will be judged by KFPS judges. Mares entered in the FHANA Central Mare Show may also enter IFSHA classes, but must be shod in accordance with KFPS keuring guidelines.		
7. Entry fee is \$150 per mare. The top two mares from each preliminary class will show back in the Championship on Saturday night, and no additional entry fee will be required.		
8. IFSHA fees are \$150 per stall and a \$25 office fee per horse.		
9. Health requirements are the same as for IFSHA. Coggins test, health certificate and proof of vaccination.

Every entry made on this entry blank shall constitute an agreement and affirmation that all participants (which shall include, without limitation, the owner, lessee, trainer, manager, agent, coach, driver, rider, handler and the horse) for themselves, their principals, representatives, employees and agents: (1) shall be subject to the rules of the FHANA Central Mare Show; (2) represent that every horse, rider, driver and handler is eligible as entered; (3) agree to be bound by the rules of the FHANA CENTRAL MARE SHOW and will accept as final the decision of the hearing committee on any question arising under said rules, and agree to hold Chamions Expo Center, IFSHA & FHANA, KFPS, their officers, directors and employees harmless for any action taken; and (4) agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death and by participating they expressly assume any and all risks of injury or loss, and they agree to indemnify and hold Champions Expo Center, IFSHA & FHANA, KFPS and their officers, directors, employees and agents harmless from and against all claims including for any injury or loss suffered during, or in connection with the competition, whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officers, directors, employees or agents of Chamions Expo Center, IFSHA, FHANA & KFPS.

I CONSENT to authorizing show management to contact the show veterinarian if, in the opinion of show management, the horse has a serious illness or injury and the owner or trainer is not readily available.
