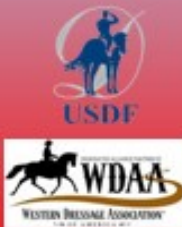

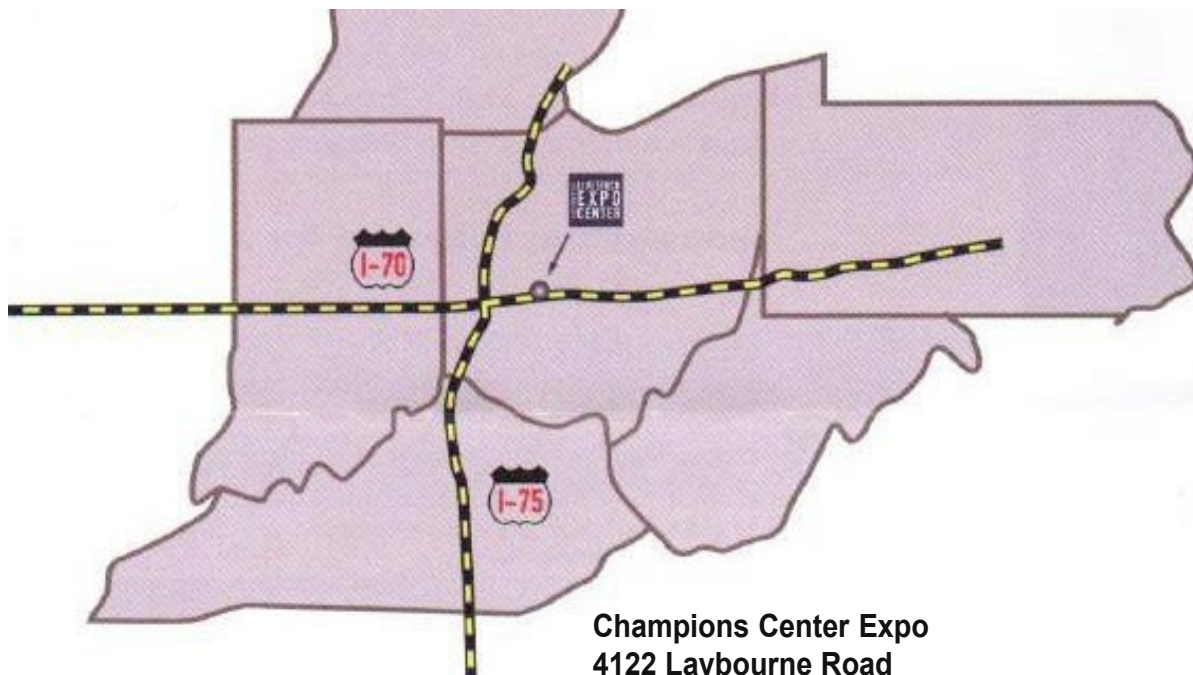

New Safe Sport Training Requirement
Approved August 27, 2018
Safe Sport USEF Rule Part 3

- Every USEF member and Federation Participant* shall abide by USEF's Safe Sport Policy and the U.S. Center for SafeSport Code of Conduct. **As described by the USEF Safe Sport Policy, a Federation Participant is any USEF member or non-member, who participates in, or attends a USEF-licensed competition or sanctioned event.*
- In order to comply with S.534, the Protecting Young Victim's from Sexual Abuse and Safe Sport Authorization Act of 2017, the USEF Safe Sport Policy, and the Center's SafeSport Code of Conduct, every USEF adult member and USEF participant, with the exception of the victim, is required to report suspected sexual misconduct within 24 hours to the appropriate authorities and to the U.S. Center for SafeSport.
- Beginning January 1, 2019, every USEF adult member with a Competing Membership must complete USEF's Safe Sport Training, as approved by the U.S. Center for SafeSport (the Center). BOD 8/27/18.**

A 30 day grace period to complete the awareness training will be provided to new members who join after December 1, 2018. Those who do not complete the training within the grace period will be ineligible to participate in USEF activities, including competitions. Renewing members must complete SafeSport before competing.

1. Class Scratch refunds will no longer be allowed without a note from the vet. You are welcome to exchange a class for the same horse and same rider. Please do this at the time of the scratch.
2. Class Additions must be done prior to the class session and according to this schedule:
 - Morning Additions will need to be done by 6:00 PM the evening before.
 - Afternoon Additions will need to be added by 10:00 AM the day of the class.
 - Evening Additions will need to be added by 2:00 PM the day of the class.
3. Four Gate holds per session with a maximum of 5 minutes will be available and must be requested before the start of each session.
4. A Two Minute Gate Hold will be Observed.
5. The Paddock Marshall will maintain an “On Deck” arena. This will be for the next class only.
6. The Warm Up Arena will be the outdoors arena directly across from the indoor.
7. The Covered Arena will be used for Dressage Warm Ups on Wednesday and Thursday.
8. When entering the “On Deck” arena, it is the exhibitor’s responsibility to physically check in with the Paddock Marshall. Please do not assume “the Paddock Marshall knows I am here”.
9. Important Notice!!! For all Exhibitors that plan to layover on Sunday night, you will need to move your horse to an outside stall. *ALL EXHIBITORS will need to be out of the INDOOR Barn on Sunday evening.*

I AGREE that I choose to participate voluntarily in the Competition, the IFSHA World & Grand National Championship Horse Show, with my horse, as a rider, driver, handler, vaulteur, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death. ("Harm").

I AGREE to hold harmless and release the Federation, the Competi-

tion, the IFSHA World & Grand National Championship Horse Show, the International Friesian Show Horse Association, and Champions Center Expo from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Federation or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation or the Competition, the IFSHA World & Grand National Championship Horse Show.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a membership of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

- 1. The 2021 IFSHA WORLD & GRAND NATIONAL HORSE SHOW is a United States Equestrian (Federation) licensed competition. Every Friesian and Part Bred Friesian class offered herein which is covered by the rules and specifications of the current Federation rule book will be conducted and judged in accordance therewith.** The rules of the Federation take precedence over the rules of any other association. Exhibitors are encouraged to refer to the current Federation Rule Book, which is available online at www.USEF.org. A Federation Steward approved by the Show Committee shall be present to administer these rules at the show.
- 2. Opportunity Classes:** Will be conducted in accordance with USEF rules. There will be no USEF membership requirement for Opportunity Classes. Entries may show in other classes at this show if their breeding allows.
- 3. Show rules will be available in the horse show office. USEF & IFSHA show rules are also available at www.USEF.org. If you have questions, please contact Sandy Jacob at 608-201-5922 (hndsnhves2@aol.com).**
- 4. AWARDS: World Championship Classes:** Trophy and Ribbon to World Champion and Ribbons to Reserve and Top Five. All Friesian classes are to be placed through 15. **Opportunity Classes:** Trophy and Ribbon to Champion and Ribbons to Reserve and Top Five.
- 5. All Friesian & Part Bred Friesian horses to be shown must have received a certificate of membership from the International Friesian Show Horse Association (IFSHA). See FR101.** Copies (front and back) of breed registration papers must be mailed with entries.
- 6. The Horse Show Executive Committee** reserves the right to itself, to interpret all questions and conditions in regard to, or arising out of, or incident to, the show, without claims for damages or recourse of any kind. Any question not covered in these rules and regulations shall be decided by the Horse Show Executive Committee, their decision to be final. The Horse Show Executive Committee is to consist of Horse Show Manager, Horse Show Secretary & IFSHA Representative.
- 7. All entries are accepted** with the understanding that the IFSHA World & Grand National Horse Show and Champions Center Expo will not be held responsible for any loss, damage or any injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the Show Committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage or injury to any person, animal or property occasioned by him, his agents or employees, or by any animal owned or exhibited by him, and shall indemnify the Federation, the IFSHA World & Grand National Horse Show, the International Friesian Show Horse Association and Champions Center Expo against any and all loss, damage and liability thus occasioned, including but not limited to any and all legal costs, including attorney fees, which may be incurred as a result thereof. The submission of an entry form to the Show shall constitute an acceptance by each person signing same of the provisions herein set forth.
- 8. All owners and exhibitors** will be held responsible for any damage incurred by them or their agents to barns or Champions Center Expo properties on the show grounds and will be billed accordingly. Stalls must be left in original condition with the exception of shavings and horse manure. Anything brought to the grounds must be removed from the grounds.
- 9. To be eligible to participate** as a rider, driver, handler, vaulter, longeur, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions at the Preliminary Level or above, Dressage Competitions, Combined Driving Competitions at the Advanced Level, Endurance Rides, Reining Competitions, ParaEquestrian Competitions and Vaulting Competitions, persons must be Members of the Federation as provided in Bylaw 203, and have paid the respective Breed/Discipline Dues. (For exceptions see GR901.9). Non-member participants must pay a non-member Single Event Show Pass fee.
- 10. Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.**
- 11. Minors** who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license.

- The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. (GR1301.7)
12. **Management reserves the right** to refuse, accept conditionally, or cancel any entries, disqualify any riders or exhibitors, prohibit entries and to cancel award prizes, without claims for damages; to change any course, to cancel or combine any unfilled classes, or to reschedule classes; and to change rings, judges or other officials.
 13. **Class Schedule:** The Class Schedule included in this booklet is *tentative*. **PLEASE NOTE THE FOLLOWING: Management reserves the right to adjust the class schedule and class order. If entries warrant, performance may begin earlier or later than published. If entries warrant, classes may be split or combined. Please check with the Horse Show Office for each day's final schedule.**
 14. **Judging: Championship Class Judging** will be by a three judge panel. (Exception: Dressage, Western Dressage, Driven Dressage, Trail, Obstacles) Each class will have a Call Judge determined on a random rotating basis. Placings will be based on the combined scores of all judges. The Call Judge's placement will break all ties. The entry with the highest total points will be awarded Champion; the entry with the second highest total score will be awarded Reserve Champion; and the remainder of the Top Five (unranked) will be third, fourth & fifth highest scores. **Opportunity Class Judging** will be by a single judge.
 15. **Carriage Driving Classes:** Will be conducted in accordance with USEF rules. Exhibitors are encouraged to refer to the current Federation Rule Book, which is available online at www.USEF.org.
 16. **Marathon Vehicles** will be allowed in all driving classes except Turnout classes and Concours d'Elegance.
 17. **Concours d'Elegance** will be judged as separate class. The winner will be the turnout which, in the opinion of the judges, presents the most elegant effect. This will include vehicle, harness, appointments, horses, driver, passengers, grooms, etc., but above all, general impression is most important. Period costumes are prohibited. (See Federation Carriage Pleasure Driving Rule CP 230)
 18. **Costume Driving.** This class shall be conducted in accordance with Carriage Pleasure Driving Rule CP 217. Exception: Whips shall wear costumes which show creativity, imagination and freedom of expression. No metal costume elements. No strong trot is called for.
 19. **Drive & Ride Classes:** In **Open Drive & Ride**, the whip and rider may be different individuals. In **Walk/Trot Drive & Ride**, the whip and rider must be the same person.
 20. **Driven Dressage** will be run in accordance with USEF Driving-Combined Driving Subchapter DC-11 Rules 933 through 942.
 21. **All Breed Exhibition Class** will be a Lead Line or Ridden Walk Only class open to all seats English or Western. Entrants may wear a costume, riding attire or barn attire. Class does not count toward the 5-performance class daily maximum and entrants may cross enter in any other division at the Show.
 22. **Friesian Horse Grooming Note:** In accordance with European standards, the Friesian horse is not required to be show clipped to be shown. Judges are not to penalize the exhibitor for an unclipped horse.
 23. **All horses may be drug tested on a random basis.**
 24. **All horses two years old and over** may have their hooves measured by the Show Steward on a random basis.
 25. **Class Fees. World Championship Classes, including Concours d'Elegance, are \$100.00, except that Junior Exhibitor Championship Classes are \$50.00. Opportunity Classes are \$100.00. Lead line-Riders 8 & Under Open to All Breeds: \$25. See Early Entry Bonus Program.**
 26. **Entries: To be accepted,** the entry blank must be COMPLETELY filled out and accompanied by a check covering all fees, plus **proof of Equine Influenza Virus and Equine Herpes Virus vaccinations within six months of show dates (see GR845) and proof of a current negative Coggins Test within twelve months of show dates for all horses.** In addition, for out-of-state horses, Federal law requires a health certificate within 30 days of traveling. • In the case of a minor the entry blank must be signed by the parent or guardian. • **If there is no trainer, the entry blank must be signed by the owner.** • All participants in the competition 18 years old and older must provide a copy of SafeSport Certificate of Completion or USEF membership card indicating Safe Sport completion. • Send the completed entry blank along with all entry fees, stall fees, all other fees and copies of front and back of Certificate of Registration, SafeSport Certificate of Completion, USEF membership card, IFSHA membership card, and, if applicable, USEF Amateur Card, and/or USDF Membership Cards to Sandy Jacob, IFSHA Show Manager, 8846 West County Rd M, Edgerton WI53534. Make checks payable to IFSHA. Numbers will be released upon full payment of all fees. No entry will be accepted and processed without the above.
 27. **Closing date is September 10, 2021. Pre-Entries must be postmarked by September 10, 2021. Post Entries** will be accepted with penalty. **Late entries** received after September 10, 2021, will pay a late fee of \$35 per horse. **Dressage entries close Sept. 1st.** All entries received after that will be placed on a Wait List, but no guaranteed ride.
 28. **Post Entry for Ridden & Western Dressage** may be accepted until Sept. 28 at 5 PM and will be on Wait List; no guaranteed ride. **No Penalty Exhibition.**

- 29. Dressage (English & Western) limited to 95 Rides: 65 on Wednesday & 30 on Thursday.** Rides will be assigned as entries are received. A waitlist will be maintained for any entries above the 95 Rides. Dressage classes may not run in listed order. *Official times will be posted in Horse Show Office by noon the day preceding the first day of competition. (Ride Times may not change except in compliance with GR830.5.)*
- 30. Dressage Times.** Provisional Times will be emailed if time permits. Official Times will be posted at the Horse Show Office *by noon the day before the start of the entire competition. It is the responsibility of the competitor to check official ride times.* Adequate time intervals cannot be guaranteed when riders enter more than one horse in any class.
- 31. Class Calls.** Due to unforeseeable problems with any mechanical device, the PA System and paddock calls must be considered a courtesy. It is the responsibility of the exhibitor to be sure that his horse is at the gate at the prescribed time. Every effort will be made to maintain a working PA System to carry class calls, however, no protest will be upheld, nor will any class be changed on the basis of PA malfunctions alone. **The two-minute gate rule will be strictly enforced.** The in gate will be closed two minutes after the first horse enters the ring.
- 32. Refunds.** Entries will only be refunded (less a \$30 handling fee) if a Vet Certificate is received within five days of the event. No refunds on stabling fees. Refunds will be issued within 30 days of close of show.
- 33. Federation Fees. For every horse participating in any competition recognized by the Federation,** a \$23.00 Federation fee will be collected. [\$13.00 is for USEF, and \$8.00 shall be a drugs and medications fee to provide for research, inspection and enforcement of rules regarding use of medications and drugs.] See Federation GR407.1, 2, 3.
- 34. USEF Single Event Show Pass Fee** is due from any participant in an Open or Junior Rider class (including at least one owner per horse) who does not have a current USEF membership card.
- 35. USEF Adult Amateur:** Amateur cards are no longer available for non-members. Only active Federation members may obtain amateur certification. Every person who has reached his/her 18th birthday and competes in classes for amateurs under Federation rules must possess current amateur certification issued by the Federation.
- 36. Office Fee.** There is an Office Fee of \$30 per horse.
- 37. Friesian Membership.** All owners/lessees and horses must be members of IFSHA.
- 38. Friesian Non-Owner Non-Member Participant.** A Non-Owner Non-Member Fee of \$25 per adult or \$20 per junior will be assessed if applicable.
- 39. Stalls (No first bedding),** whether occupied by horses, feed or tack, will be available for a fee of \$150 each for the entire show (*defined as Monday through Sunday.*) Bring your own buckets and snaps. **Overnight Stalls:** \$100 per stall for use on one day & night; out by 9am the next morning. **Day Stalls:** \$65 per stall for use in & out the same day. **Hospitality Stalls:** You may use stall(s) for socializing and farm information for a fee of \$65 each for the entire show. Front panels may be removed but must be replaced. No feed or tack may be stored in a hospitality stall.
- Stall availability.** 10' x 10' permanent stalls, with asphalt flooring and sliding doors, will be available on Monday, September 27th, 2021, at **NOON**; all stalls must be vacated by 10:00 am on Monday, October 4th, 2021. Early arrivals must be pre-arranged with Sandy Jacob at 608-201-5922 and will be Outdoor Stalls due to a prior show; late departure (\$45 per stall per day) arrangements should also be made with Sandy Jacob at 608-201-5922. Horses that will need to overnight at the close of the show will need to be moved to the outdoor stalls at the Champions Center. Due to the heavy show schedule, Champions cannot accommodate horses in the indoor barn for 2021.
- 40. Bedding: No outside bedding allowed.** Shavings/Bedding is available at the show for \$9.00 per square. Please order your bedding in advance on your entry blank. Once at the show, order bedding through the Show Office.
- 41. Videography & Photography:** IFSHA World & Grand National Horse Show does not allow freelance videographers and/or photographers. **Only official vendors, i.e. videographer Be In View, photographer Avalon Photography, may photograph horses in the Show Arena.** Only Trade Faire vendors, are allowed to work on the show grounds and sell their products while the facility is under contract for the IFSHA World & Grand National Horse Show. **If professional equipment is observed in the Show Arena, you will be asked to remove your equipment.** There shall be no signage allowed advertising other videography or photography companies.
- 42. Food Service.** During the competition, food service will be available on the competition grounds.
- 43. Sharps** must be disposed of in the containers provided for that purpose. Red biohazard containers can be found throughout the barn area. Do not place needles, syringes and medical waste in the trash. Show management will fine any individuals, including trainers, owners, exhibitors or their agents, **up to \$1,000** for improper disposal of needles or other sharp disposable instruments.
- 44. Protective Headgear** is encouraged at all times on the grounds and in any and all classes. ASTM/SEI approved protective headgear is required for riders in all Dressage, Hunter, Jumper and Hunt Seat Equitation classes, including Hunter Hack. Junior riders in said classes, and Dressage exhibitors not cross entered in another Division, are required to wear said headgear when riding anywhere on the competition grounds. Any exhibitor may wear said headgear and/or equestrian sport protective vest in any division or class without penalty from the judge.
- 45. Welfare of the Horse:** Upholding the welfare of the horses exhibited here is of primary concern to our management team. We require that all horses are treated with the kindness, respect and compassion they deserve and they should never be subject to mistreatment. Owners, trainers,

riders and grooms or their agents, must use reasonable care in the handling and treatment of the horses owned and/or placed in their care for competition or for any other purpose. We will provide for the continuous well-being of the horse by vigorously enforcing the rules of the USEF which pertain to the welfare of the horse. Exhibitors are cautioned that GR839 which defines the USEF policy on abuse, GR844 which pertains to poling, and GR803 which pertains to the use of whips, will be strictly enforced. No excessive use of whips or poling will be tolerated. Violators are subject under the above rules to elimination from competition and to protest or charge with resulting formal proceeding which may result in severe fines, suspensions or other penalties. All incidents will be reported in the Steward's Report and reviewed by USEF's Executive Director/CEO for possible further investigation and charges for hearing before USEF's National Hearing Committee.

46. **No Smoking:** Smoking is prohibited in any building and around any of the barns. Show management will fine any individual found smoking in a non-smoking area \$100 per incident.
47. **Dogs must be on leashes no longer than 6 feet.** Individuals must not lead a dog while mounted. No loose dogs are allowed. Per USEF Rule GR1301.6, dog owners who fail to comply with these rules will be issued a Yellow Warning Card and may be subject to penalties under Chapter 6 and 7.
48. **Vehicles:** Motor vehicles are prohibited within stable facilities except to load/unload horses, tack and/or feed unless authorized by show management. After unloading, all vehicles must be parked in a designated parking place for that particular vehicle as soon as unloading is completed.
49. **Parking:** Specific areas have been set aside for parking of horse vans and trailers. All trailers must be parked at the north end of the stabling area. All trailers must be parked away from the building. All violators will be ticketed and towed at the owner's expense.
50. **Showers:** Showers are available in the front restrooms area. Nighttime access is made by using the front doors to the restrooms located on the south side of the Champions Center at the main entrance.
51. **No Firearms, fireworks or open fires** are permitted.
52. **Show Fines:** The following fines will be enforced by the show on all show participants in violation of local rules: a) Smoking in buildings and around barn areas: \$100, and b) **Improper disposal of sharps or medical waste: up to \$1,000.**
53. **Indoor On-Deck Arena** is 125 feet long by 80 feet wide. The footing is washed concrete sand.
54. **Indoor Show Arena** is 200 feet long by 125 feet wide. The footing is washed concrete sand.
55. **Outdoor Work Ring** (uncovered) is 300 feet long by 200 feet wide. The footing is masonry sand.
56. **Pavilion Warm Up Arena** is 74 feet long by 130 feet wide. The footing is composed of masonry sand.

57. **Pavilion** is 274 feet long by 130 feet wide. The footing is composed of masonry sand.
58. **Grass Court** footing is grass with sand clay base; arena dimensions for Driven Dressage set up per USEF Driving-Combined Driving Subchapter DC-11 Rule DC934.
59. **Horse Show Office** will be open Tuesday, 9-28-21, from 9 am to 5 PM. The office will open one hour prior to the first session each day and remain open for 30 minutes after the last class each day. **The Horse Show Office telephone number is 314-717-7683.**

DEFINED TERMS The term "Event means IFSHA World and Grand Championship Horse Show 2021 currently scheduled to be held on September 29 thru October 3, 2021 at The Champions Center, Springfield, OH . The Event is owned, produced and managed by International Friesian Show Horse Association ("IFSHA"). As used hereinafter, the term "Organizer" means, collectively, IFSHA and its officers, directors, members, agents, representatives and employees, unless the context requires otherwise. The term "Exhibitor" means, collectively (1) the company or person that applied for exhibit space rental and agreed to enter into this contract upon acceptance by IFSHA and (1) each of its officers, directors, shareholders, employees, contractors, agents, representatives and/or invitees as applicable.

ASSUMPTION OF RISKS; RELEASES Exhibitor expressly assumes all risks associated with, resulting from or arising in connection with Exhibitor's participation or presence at the Event, including, without limitation, all risks of theft, loss, harm, damage or injury to the person, (including death), property, business or profits of Exhibitor, whether caused by negligence, intentional act, accident, act of God or otherwise. Exhibitor has sole responsibility for its property or any theft, damage or other losses for such property, including all subrogation claims by its insurer. Neither Organizer nor the Exhibit Facility accepts responsibility, nor is a bailment created, for property delivered by or to Exhibitor. Neither Organizer nor the Exhibit Facility shall be liable for, and Exhibitor hereby release, all of them from, and covenants not to sue any of them with respect to, any and all risks, losses, damages and liabilities described in this paragraph.

Exhibitor agrees that the courts located in the State of OHIO shall constitute the exclusive forum for the resolution of any and all disputes arising out of, connected with or related to this contract or the breach of any provision of this contract. Exhibitor waives any right to assert lack of personal or subject matter jurisdiction and agrees that venue properly lies in Ohio.

BOOTH ASSIGNMENT While initial booth reservation is mutually agreed to by Exhibitor and Organizer, final assignment is the proprietary right of Organizer. Every attempt will be made to locate the Exhibitor in a booth he or she has requested but, in extenuating circumstances, the booth can be reassigned without approval of Exhibitor. Exhibitor shall not assign, sublet or apportion the whole or any part of the space assigned or have representatives, equipment or materials from firms other than its own in the exhibit space without written consent of Organizer.

SET UP AND REMOVAL OF EXHIBIT All exhibits must be entirely set up by Event opening at 8:00 a.m. Wednesday, September 29, and may not be removed prior to Event closing at 6 p.m. Sunday, October 3, 2021. In the event an Exhibitor has failed to occupy the space contracted for by 8:00 a.m. on Wednesday 9/29/2021 Organizer shall have the right to utilize such space in any manner he chooses. This will in no way release the contracted Exhibitor nor shall Exhibitor be entitled to any refund. Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.
